# **Hauling to WEGI – South Landfill**

WEGI is proud to offer a safe, convenient and environmentally friendly site for non-hazardous solid waste disposal. We are providing our customers, and their haulers with information that will keep our site safe and in compliance with our approvals.

**Site Location:** 3081 Taylor Road, Niagara Falls, ON (Between Thorold Stone Road and Mountain Road)

Waste Types: ONLY Solid non-hazardous waste (including asbestos) is accepted at the site.

Site Access: All Trucks must enter and leave the site using the entrance on Taylor Road.

**<u>Haul Routes:</u>** Please review the maps on the following pages.

**Tractor Trailer Units** must access Taylor Road entrance from: Route A: Hwy. 406 to Highway 58 through the Seaway tunnel to Thorold Stone Road

#### DO NOT USE THE GLENDALE AVE. OR THE MOUNTAIN ROAD EXITS OFF THE QEW.

**Local Collection Units** may use any of the following routes to access our Taylor Road entrance: Route A: Highway 58 (through the Seaway tunnel) Route B: Thorold Stone Road Route C: Thorold Townline Road Route D: Mountain Road Route E: Taylor Road, south of Glendale

**Service Area:** Only waste that is generated in the Province of Ontario will be accepted at the site.

Hours of Waste Receipt: Monday – Friday: 7:00 a.m. - 5:00 p.m. Saturday: 7:00 a.m. - 1:00 p.m.

NOTE: The site is closed on Sundays and Statutory Holidays

#### **Hours of Truck Staging:**

The main access gate will open at 6:00 a.m. to allow staging within the site.

TRUCKS MUST NOT ARRIVE PRIOR TO 6:00 A.M. AS THERE IS A STRICT "NO STOPPING" POLICY ON TAYLOR ROAD.



# Walker Environmental Group Inc. – South Landfill Environmental Overview

**Speed Limits:** The speed limit for paved roads on site is **50 km/hour**. The speed limit for non-paved roads on site is **25 km/hour**.

**No Scavenging:** There is no scavenging permitted at the site.

### **Environmental Inspector:**

This site has an on-site Ministry of the Environment Inspector. The inspector may be present daily and will be monitoring our site and our customers (including hauler) for compliance with Environmental Legislation.

## **Driving in Our Community:**

- Drive with awareness, drive defensively
- Obey all speed limits and traffic safety signs
- Refrain from using your engine brakes
- Please ensure your vehicle is properly maintained

#### **Enforcement Program:**

Compliance with our site rules is very important. We will maintain a community traffic enforcement program to ensure traffic rules around the site are being followed. Our operating staff continuously monitor compliance while on our site. Our progressive discipline program is as follows:

## 1<sup>st</sup> and 2<sup>nd</sup> offences:

The Walker Industries Health & Safety Representative will notify the driver that they exceeded a posted speed limit, disobeyed traffic rules or used a haul route other than that designated. The details will be entered into our Driver Safety Catalogue. The information will also be communicated to their dispatcher and/or customer.

If the Safety Representative is not able to contact the driver personally, the dispatcher and/or customer will be notified with the time of day and truck number to identify the driver. The dispatcher and/or customer will be notified of the offence, and requested to discuss the events with the employee.

3<sup>rd</sup> Offence: The driver will not be permitted to enter our properties for a period of three (3) days.

**4**<sup>th</sup> **Offence:** The driver will not be permitted to enter our properties for a period of one (1) week.

**5**<sup>th</sup> **Offence:** The driver will be no longer permitted on-site.
